Commitment to Community Campaign – Municipal Elections:

- Deena spoke about the upcoming municipal election campaigns with all the changes happening. She mentioned that the goal of the campaign is to fully fund TO Prosperity Platform (Toronto's Poverty Reduction Strategy) where until now social housing, recreational, middle childhood and many other programs remain unfunded.
- Commitment to Community campaign is working hard to make candidate councillors accountable for the full funding TO Prosperity Platform (Toronto's Poverty Reduction Strategy) by creating tools and fact sheets in 6 different languages that are downloadable from Social Planning Toronto's website.
- She also spoke about importance of uplifting communities in Toronto and raising awareness on Prosperity Platform Campaign. She explained the different usage of TO Prosperity Platform tools and the 2018 Toronto Election Candidate Pledge on Poverty Reduction. She added that Social Planning Toronto is contacting all the municipal election candidates and will publish a list of who signed the pledge and who did not.

MCMCT Survey Update and next steps with focus areas:

- Lisa S. mentioned that one of the survey results on Coalition Structure & MCMCT Focus Areas was having more lunch and learns.
